The Odera-Orika Symposium will be held on Tuesday, 19th to Thursday 21st, November, 2013 at the Goethe Auditorium, Nairobi. Scholars from around the world will congregate at the auditorium to commemorate the late professor's contribution to philosophy.

The late Kenyan Professor of philosophy (1944-1995) contributed immensely to the growth of contemporary African philosophy and helped locate African philosophy within global philosophical discourse. His works are in areas such as normative and applied ethics, epistemology, and most notably, philosophic sagacity.

The works continue to inspire many and play a major role in the current debate on African philosophy.

Professor Odera-Orika will be remembered as one of the founders of *Thought and Practice: A Journal of the Philosophical Association of Kenya*. The journal is currently an online, open access, bi-annual peer-reviewed publication, and is found at <http://ajol.info.index.php/tp/index>

Mr. Uchenna Emelonye, Senior Human Rights Advisor based at the United Nations Headquarters, Gigiri, Nairobi, Kenya, will deliver a guest lecture to over fifty Master of Arts Degree in Human Rights students at the Department of Philosophy and Religious Studies Resource Centre, Friday 20th June, 2013. The topic of the lecture is: *The Prospects and Challenges of Mainstreaming Human Rights and Peace in Post-Conflict*

Situations in Africa.

This lecture is part of a long tradition of the Department's seminar series which ensures partnership with professionals and stakeholders in line with the Universities core value of professional development that bridges theory, practice and professionalism.

Mr. Emelonye joined the United Nations, Nairobi office, from the International Development Law Organization, IDLO, Rome, where he served as Head of Institutional and Justice Reform Programs.

Among other things, he oversaw IDLO's tellurian work with governments, including providing technical support to a Committee of Experts in drafting the Kenya Constitution 2010.

He also worked in a similar capacity in Somalia and Afghanistan; and was instrumental in the strengthening of the national Human Rights

Commission of Ethiopia.
